- The demand for outdoor swimming facilities and the value placed on these facilities by the community
- The desire for an inventory of lost facilities and (plans for) their replacements

• The desire for information related to the capital and operating cost implications of new facilities in order that the Committee can understand the City-wide impact of requests for these facilities
