ADD New Clause 1.5.5.1:

Relocation of the existing Park Information Sign will be considered incidental to work in other sections.

SECTION 32 31 13S (CHAIN LINK FENCES AND GATES)

ADD New Clause 1.5.5

Relocation of existing bollards will be considered incidental to work in other sections.

QUESTIONS AND CLARIFICATIONS:

Q1.) The 'Combined Drawings' pdf is missing sheets 4-6 (Pinetree Way traffic signal) in the DMD drawing package (starts on page 24).

- A1.) Please refer to the Supplementary Contract Specifications, Section 00 72 43S, sub-section 1.02: The Guildford Way and Pinetree Way intersection electrical drawings will be provided during the tender process.
- Q2.) Could you please clarify if CB01 and CB03 are existing or new?
- A2.) All of the catch basins, regardless of the type, are proposed unless otherwise noted on the Contract Drawings.
- Q3.) Item 9.03 CB removal & disposal 21 each, my takeoff is 29 each, could you please address this item?
- A3.) Refer to FORM OF TENDER: *Revised* Appendix 1 Revision No. 1, Pay Items 9.03.
- Q4.) Bid item 21.07 indicates 5 CB adjustments, my takeoff shows 7, please clarify.
- A4.) Refer to FORM OF TENDER: *Revised* Appendix 1 Revision No. 1, Pay Items 20.07.
- Q5.) Bid item 4.05 indicates 115 LM of Band curb, my takeoff shows 193, please clarify.
- A5.) Refer to FORM OF TENDER: *Revised* Appendix 1 Revision No. 1, Pay Items 4.05.
- Q6.) Which bid item should the sod removal & disposal (920m2 * 0.3m =276m3) be in?
- A6.) Sod removal and disposal will be paid for under line item 9.04 Common Excavation (Incl. Offsite Disposal).
- Q7.) Please clarify which bid item "ADJUST EX. CHAMBER TO FINAL GRADE (TYP.)" is to be included in.
- A7.) We will install the new sidewalk/bike lane so it works with the current grade of the chambers.
- Q8.) Please clarify which bid item "RELOCATE BIKE LOCKER" is to be included in.
- A8.) The existing bike locker will be relocated by others.
- Q9.) Please clarify which bid item "RELOCATE EXISTING BOLLARDS TO BACK OF NEW TYPE E CURB (TYP.)" is to be included in.
- A9.) Refer to Supplementary Contract Specifications, revised Section 32 31 13S, Sub-Section 1.5.5.

- Q10.) Please clarify which bid item "RELOCATE PARK INFORMATION SIGN" is to be included in.
- A10.) Refer to Supplementary Contract Specifications, revised Section 32 17 23S, Sub-Section 1.5.5.1.
- Q11.) Could you please label the trees to be removed and / or relocated, after printing the drawing with heavyweight line types, we are unable to clearly identify these trees. I understand tree removal is bid item 7.01, which bid item would include tree relocation?
- A11.) All trees marked for removal on the Contract Drawings are to be removed. The Sequoia tree at the northwest corner of Pinetree Way and Guildford Way is the only tree to be relocated, which will be done by others.
- Q12.) Please clarify if the Tactile Warning tiles are surface applied, cast in place, or tactile pavers.
- A12.) Please refer to the Supplementary Contract Specifications Section 03 30 20S, Sub-Section 2.1.7: The tactile warning surface tiles shall be replaceable cast-in-place style.
- Q13.) There is a line item for eradication but from the roadworks/pacing limits don't show any. Please confirm if this item is required and confirm where the eradication would need to be completed.
- A13.) Line painting eradication and temporary pavement markers are required to ensure safe lane widths are maintained during construction and after hours.

 The *Contractor* is required to ensure safe travel for vehicles during construction.
- Q14.) There is a line item for removal of one cat eye reflector but we don't see it on the drawings. Please confirm if this will be required and confirm where on the drawings we can find it.
- A14.) There are recessed snowplowable reflective pavement markers (cat-eye) along the centre lines of the road on Guildford Way, which need to be eradicated.

 These will be paid for as a lump sum amount. Please refer to FORM OF TENDER Appendix 1.
- Q15.) Note #2 on Dwg. No. 04 of 22 on the civil drawings for the Bus Stop Barrier Fence Section Detail says "All components to be stainless steel", however the Tender Forms,

item 15.01 and page 101 of the contract documents state that the bus stop barrier fence is MMCD C14 powder coated black. Please confirm which is correct and if there are any other components the Contractor should be made aware of that are to be stainless steel.

A15.) The Bus Stop Barrier Fence is to be MMCD C14 powder coated black. The mounting components are to be stainless steel.
