#### BYLAW NO. 3479, 2001

#### A Bylaw to Adopt the City of Coquitlam Citywide Official Community Plan

WHEREAS the Council of the City of Coquitlam wishes to adopt a Citywide Official Community Plan for the City of Coquitlam, after the Public Hearing in accordance with the Local Government Act, R.S.B.C. 1996 Chapter 323:

NOW THEREFORE, the Council of the City of Coquitlam, in open meeting lawfully assembled, ENACTS AS FOLLOWS:

- District of Coquitlam Southwest and Town Centre Official Community Plan Bylaw No. 1833, 1988; District of Coquitlam Maillardville Official Community Plan Bylaw No. 2071, 1989; City of Coquitlam Northeast Coquitlam Official Community Plan Bylaw No. 3368, 2000; and District of Coquitlam Northwest Coquitlam Official Community Plan Bylaw No. 2441, 1992 and all amendments thereto are hereby rescinded.
- Schedule 1, and all attachments hereto are hereby together designated as the "City of Coquitlam Citywide Official Community Plan, 2001".
- 3. This Bylaw may be cited for all purposes as the "City of Coquitlam Citywide Official Community Plan Bylaw No. 3479, 2001".
