Dear Chief Election Officer,

The Canadian Labour Congress (CLC) registered as a campaign organizer for the 2008 local elections in your jurisdiction. Attached is the required disclosure on our province-wide campaign for your jurisdiction.

The CLC is a central labour organization that has historically participated in local elections, working with our affiliated labour councils, our affiliate trade unions, and our provincial BC Federation of Labour. Our labour councils take the lead by working with local candidates, and recommending which of them, if any, should receive an endorsement. The affiliated unions and the federation then work with us to distribute those endorsements to our members for their information.

We paid expenses directly for some labour councils. In addition, many of our affiliates and other labour councils have donated the value of their activities as an in-kind donation to the CLC campaign. Mailings and distributions of the labour council endorsements have occurred throughout areas that invariably encompass many jurisdictions.

The Campaign Organizers Guide was not published until the election process was well under way, and that delay did cause us some uncertainty. We paid for some expenses out of our election account, listed as Visioning under the "Other" category, that we no longer believe should be defined as election expenses. We are reporting them in any case because of their payment out of that election account.

The Act requires the reporting of the surplus in the campaign account for the candidate only, not for a Campaign Organizer. It lists no requirements for a campaign organizer surplus, either for reporting or for its distribution after the campaign. Accordingly, we have indicated "N/A" in that section of your forms.

In addition, our organization, working with a number of our affiliates, attempted throughout the spring to get clarity from the provincial government regarding the treatment of the multiple jurisdiction campaigns that we historically run. The Campaign Organizer Guide, at Page 30, notes that;

“Campaign organizers or elector organizations that conducted election **campaigns** in multiple jurisdictions are required to complete the filing requirements in each of those jurisdictions. The financial agent may produce a single report for the overall election campaign, including activities in each of the jurisdictions where candidates were endorsed.”

We have produced that single report, and have attached a list of all candidates in the province for whom we campaigned as a campaign organizer. All declarations have been notarized, and we believe meet the requirements of the Act and are consistent with the guide.


